**\*\*SPECIAL MEETING\*\***

The College of Education and Human Development Curriculum Committee met on Monday, October 9, 2000, in Room 231 of the Cate Teacher Education Center. The following members were present:

**I. CALL TO ORDER**

Dr. Alessi called the meeting to order at 1:00 p.m.

**II DEPARTMENT OF HUMAN DEVELOPMENT**

1. Dr. Canfield requested that SOC 411 be deleted from the "Fourth Year, First Semester" of the Social Work curriculum summary.

The motion was made to approve the deletion of this course from the Social Work curriculum. Moved, seconded, and approved. VOTE PASSED.

2. Dr. Canfield proposed numerous catalogue changes to the curriculum in Social Work. They are as follows:

SW 304 - add SW 202 as a prerequisite because it will be required for professional standing under current revision proposals.

On page 164 of the catalogue, delete all text which makes reference to a minor in social work. The current listing will result in a major finding in the next accreditation review.

SW 205 - Change title from "Human Diversity: Race and Ethnic Relations, Populations at Risk" to "Human Diversity and Populations at Risk".

SW 305 - delete all current prerequisites and ADD SW 304 as a prerequisite.

SW 406 - delete all current prerequisites and ADD SW 304.

SW 402 - add SW 201 and SW 205 as prerequisites.

SW 201 - add SW 101 to the current prerequisite of SOC 101.

Entry under entry, "Admission to Professional Standing in Social Work", delete I. paragraph "A", "Admission Procedures", as these procedures are no longer followed.

Also under "Admission to Professional Standing in Social Work", delete the last sentence in paragraph "C" which reads, "It should be noted that SW 201 and SW 205 are required prerequisites for SW 203." The statement is incorrect. Under "Curriculum in Social Work", change sequence of courses.

It was asked that the earlier deletion of SW 411, Race and Ethnic Relations, be rescinded and that the course only be changed.

"Social Science Elective" listed in "Fourth Year, First Semester" should be listed as "Social Science/Social Work Elective". "Social Work" should also be added to the list of courses on footnote #3 which follows the curriculum summary.

The motion was made to approve all of these changes. Moved, seconded, approved. VOTE PASSED.

### III ADJOURNMENT

Committee members were reminded that this would be the last meeting of the semester.

The meeting was adjourned at 1:45 p.m.
