I. CALL TO ORDER

Dr. Nauman moved that the by-laws be waived and the Human Development proposals be considered so that if approved, they could be considered by the Council for Teacher Education next week.

II APPROVAL OF MINUTES

The minutes from October 9, 2000 were approved as written.

II DEPARTMENT OF HUMAN DEVELOPMENT

- 1. Dr. Debbie Johnson presented the following proposals for course changes in the area of Family and Consumer Science:
- FCS 221 change in prerequisites and course description
- FCS 301 change in prerequisites and course description
- FCS 331 change in prerequisites and course description
- FCS 346 change in prerequisites and course description
- FCS 484 change in prerequisites and course description
- FCS 465 change in prerequisites and course description

Discussion developed concerning a lack of a description of field experiences in the courses. It was agreed by consensus that the phrase "field based experiences required" would be added to the course description for FCS 221, 301, and 484.

The motion was made to accept these changes. Moved, seconded, and approved. VOTE PASSED.

A discussion developed concerning the form of the syllabus for each course. By consensus it was agreed that the syllabi should be revised to fit the NCATE approved Generic Syllabus form.

The motion was made to accept. Moved, seconded, and approved. VOTE PASSED.

- FCS 482 Family and Consumer Sciences Practicum
- FCS 483 Entry level internship
- FCS 490/590 Occupational Family and Consumer Science
- FCS 611 Special Studies in Family and Consumer Science

The motion was made to delete these courses. Moved, seconded, and approved. VOTE PASSED.

4. Dr. Canfield announced that his Social Work area had proposals to be considered but he did not have those proposals for review by the committee. It was agreed by consensus to hold a special meeting next Monday, November 13, 2000 to consider the Social Work proposals.
