I. <u>APPROVAL OF MINUTES</u>

There were no minutes presented for approval.

II. <u>DEPARTMENT OF COUNSELING, FAMILY STUDIES, & EDUCATIONAL</u> <u>LEADERSHIP</u>

Dr. Ann Nauman presented changes to the course, Library Science Administration 580--School Library Practicum, (LSA 580), which is found on pages 200 & 296 in the 1997-98 SLU Catalogue, in order to make the course more relevant and meaningful for graduate students.

1) Changes in the course prerequisites to read: *Teacher Certification or eligibility, Library Science Education 501 or 502 or Library Science 610, and Library Science Administration 503, 505, and 506.*

2) Students will now receive a grade of "A" or "B" on their seminar performance and term project. Any grade below a "B" will be considered unsatisfactory. The grading scale will be: 93 - 100 = A and 85 - 92 = B.

The motion was made to approve changes to LSA 580. Moved, seconded, and approved. VOTE PASSED.

III. DEPARTMENT OF SPECIAL EDUCATION

Dr. Gayle Melville presented a change in course requirements for a degree in Special Education. The course SPED 662 would be deleted and replaced with SPED 612, Behavioral Assessment and Intervention. The Department agreed that SPED 612 would strengthen the core courses required in the Masters Degree program in Special Education.

The motion was made to approve the change in course requirements from SPED 662 to SPED 612. Moved, seconded, and approved. VOTE PASSED.

Dr. Paula Currie presented editorial changes in both Speech, Language, and Hearing and Communication Sciences and Disorders course titles, descriptions, and prerequisites.

1) On page 209, *Department of Special Education*, and page 265, *Master of Science*, *Communication Sciences and Disorders, Admissions Requirements*, the current course descriptions are incorrect and misleading. Changes to these descriptions would both correct and clarify (see attached).

2) On page 210, *Curriculum in Speech, Language, and Hearing Specialists (K-12)*, under *Fourth Year*, two typographical changes need to be made because they are not correct in the current catalog:

a) Speech, Language, Hearing 481 should read Special Education 481

b) Special Education 413 should read Special Education 365.

3) On pages 361, the course description (see attached) for SLH 101 needs to be changed to better describe the course contents.

4) On the following pages, the titles and course descriptions would change (see attached) in order to more accurately describe the course and its contents:

- page 362; the title of SLH 201 would read Introduction to Audiology
- page 351; the title of SLH 202 would read *Clinical Methods for Communication Disorders*

- page 362; the title of SLH 205 would read *Phonetics*
- page 362; the title of SLH 212 would read Articulation and Phonological Disorders
- page 351; the title of SLH 300 would read *Beginning Clinical Practicum in Speech*, *Language and Hearing*
- page 351; the title of SLH 309 would read *Diagnostic Procedures in Speech-Language Pathology*

6) Dr. Currie also presented the following course deletions:

- page 363; SLH 435 this course is not in the undergraduate curriculum and has not been offered in many years
- page 364; CSD 605 this course is being replaced by a new course, CSD 627, Neuropathologies
- page 365; CSD 620 this course is better presented as a seminar because of its narrow focus and specialization
- page 351; CSD 625 this course is no longer necessary for the major

7) Dr. Currie also requested the addition of a new course, CSD 626, *Autism Spectrum Disorders*, credit 3 hrs. This course is needed due to a new understanding of autism as a spectrum disorder, many more children are receiving the diagnosis. Care providers need to understand the unique needs of the population. This course has been successfully taught as a special topic over the past two summers. SLU is the only university in the state to offer such a course and community support is strong.

8) A request was made for a second new course, CSD 627, *Neuropathologies of Communication*, credit 3 hrs. This course would replace CSD 605, Cerebral Palsy. The new class would continue to address cerebral palsy, but would also survey other common neuropathologies. SLU students should be prepared to deal with a full range of neurogenic disorders.

The motion was made to approve all of the above changes, deletions, and new courses. Moved, seconded, and approved. VOTE PASSED.

IV. DEPARTMENT OF KINESIOLOGY AND HEALTH STUDIES

Dr. Betty Baker presented changes which resulted from the Board of Regents mandate that the two degrees offered by the Department of Kinesiology and Health Studies be combined into one. The changes are in degree titles listed in the 1997-98 catalogue on pages 250 and 256.

The motion was made to approve the above changes. Moved, seconded, and approved. VOTE PASSED.
