ELIGIBILITY: Eligible applicants are profit and non-profit organizations and applicants which may include; individuals, universities, foundations, associations, and corporations.



FUNDING: The amount of the grant award may vary based on the strength of the application and the number of applicants. Projects that are awarded a grant must be complete within 6 months of the date of the acceptance letter (unless otherwise agreed upon).
