#### VIII. Unfinished Business

A. FA23-16 A finance bill to sponsor International Night for the Department of World Languages and Culture.

Bill is still being reviewed by Appropriations.

B. FA23-17 A bill to amend the Student Government Association Bylaws Title V: Impeachments Clause 2: Executive and Legislative Impeachment Trials Section 2 and Subsection 2.4

Applicant: This currently reads "Trials of impeachment for members of the Executive branch". I believe that this is meant to say "legislative and executive branch". I also noticed that section 2.4 states the word "impeach" but I believe that this is meant to say "removed" and would like to change it. Impeachment is different from actually being removed and here what is meant is someone being removed.

C. FA23-18 A bill to amend the Student Government Association Bylaws Title IV: Judicial

Branch Clause 3: Justice Duties Subsection 1.5, Add Subsection 1.6

Applicant: This bill would add organizational visits to the Judicial Branch. We already

lowered the amount that the Senate had to perform to 1, so this would just take its

place. This gives more representation of SGA as a whole instead of just one branch.

Senate chair opens floor for discussion.

Senator Matthews: I like this and feel that it gives representation to all of SGA instead of

only the Legislative branch.

13/13 Senators vote aye, 1 abstain, bill is adopted.

D. FA23-19 A bill to appoint Abigail Cloud to the Student Government Association as a

Senator at Large.

Applicant: I am a History major and in the Honors program. I know what I want to

accomplish and have prior leadership experience. I was a co-committee chair for

the theater club here on campus but I am not anymore. Moving forward, I'd like

student workers to be unionized which will hopefully lead to all of campus to being

unionized.

Senator Smedley: Do you have any other leadership experience?

Applicant: Not currently.

Senator Matthews: What is your classification?

Applicant: I am a sophomore.
