Undergraduate MFA Plan: 2001-2002 Results

Department of Accounting Faculty:

Attached you will find a copy of the results of the 2001-2002 assessment activities. The outcome data collected for the undergraduate MFA plan comes from the 2001-2002 Undergraduate Exit Survey administered by Institutional Research to graduating seniors, the department's Internship Survey for Spring 2002, and the most recent Undergraduate Alumni survey (1999), as well as various University and departmental records. The results indicate many areas of strength and few areas of concern.

Areas of Concern Indicated in the Report and the Committee's Recommendation:

- E2, Item 1:

Only 74% students successfully completing Accounting 221 made a grade of "A" or "B" on the practice set which is completed at the beginning of the course. This expected outcome was established by the committee as a measure of the

effectiveness of Acct. 200.

- E6,

Items 1&2:

On both the alumni survey and the exit survey, we did not reach our 80% satisfaction goal regarding development of computer skills.

Regarding the alumni survey results, the committee believes that the alumni survey data is so dated at this point in time that it does not provide feedback on which we can make recommendations. A new alumni survey should be published soon. Trends in alumni data will be observed over time as we move forward. The committee recommends a monitoring approach to these results at this time.

Regarding the exit survey results, the committee believes that it is possible that the language in the question skews the results. An institutional question in the exit survey regarding "the use of technology in the classroom" was substituted for a departmental question about "computer skills." The committee recommends a monitoring approach until additional exit survey data can be obtained to determine student response to the departmental question about development of computer skills.

E7, Item 1: On the exit survey, we did not reach our 80% satisfaction goal for opportunities for interaction with the profession.

The committee recommends that we attempt to do a better job of notifying students about the opportunities they have through IMA and Beta Alpha Psi. While it is true that not every student can be a member of Beta Alpha Psi, they can join IMA and have exposure to the profession. The committee also recommends that the question's wording be changed to mention "Business Week," "IMA," etc. to remind students of the opportunities they have to interact with the profession. The committee recommends that we take a monitoring approach until additional exit survey data can be obtained to determine student response to this changed wording.

E8, Item 1: On the alumni survey, we did not reach our 80% satisfaction goal for level of exposure to group work.

An institutional question on both the alumni and exit survey regarding opportunities to collaborate with students on class projects was substituted for the departmental question about exposure to group work. The exit data suggests that students are satisfied, while the alumni survey indicates that this group does not feel that opportunities were sufficient. Because the alumni data is somewhat dated at this point, the committee recommends a monitoring approach until additional alumni and exit survey data can be collected to determine student response to the departmental question regarding exposure to group work.

E9, Item 1: On the exit survey, we did not reach our 80% satisfaction goal for placement services.

The committee recommends that the question's wording be changed to remind students of the opportunities provided by Placement Services such as the Career Fair and on-campus interviews. The committee feels that a monitoring approach should be taken until additional exit survey data can be collected to determine student response to this changed wording.

Additional Questions and Surveys:

As a result of the transition between committee chairs, we failed to add questions to the exit survey instrument concerning the ethics lecture, student exposure to global accounting and business issues, and group work. These will be added and/or substitute questions already in the instrument will be used in the Spring, 2003 semester. During the semester, a Department of Accounting survey instrument will be developed to answer specific questions that address the expected outcomes in the MFA plan. This instrument is needed because Institutional Research and Assessment only allows us to add a certain number of questions to their survey and we will be unable to collect all the data we need given this limitation.

Department of Accounting Curriculum Committee:

Regarding the issue of an insufficient percentage of students making a grade of "A" or "B" on the practices set in Acct. 200, there are several possible interpretations of these results. However, the committee is of the opinion that this is a serious enough concern to refer it to the department's curriculum committee for further study. We suggest that the curriculum committee take these results under consideration as it examines the future course of Acct. 200.
