**Department of Visual Art + Design**

1. Catalogue Change – The department of Visual Art + Design requests a change in the printmaking concentration within the Bachelor of Art degree. This request would allow students in the first and second semesters of their third year to choose from ART 317, 318, 319, or 397. **Approved**
2. Catalogue Change – The department of Visual Art + Design requests a change in the core courses for each concentration within the Bachelor of Arts degree. This request would allow students to choose between ART 281 or ART 117. **Approved**
3. Catalogue Change – The department of Visual Art + Design requests a change in the catalogue listing for the concentration of Painting. This change will allow students who are concentrating in Painting the opportunity to take ART 117 (Printmaking I) in their third year first semester and the option of choosing between ART 388 (Special Topics Drawing and Painting) or ART 311 (Advanced Drawing) in their third year second semester. **Approved**
4. Catalogue Change – The Department of Visual Art + Design requests a change in the catalogue listing for the concentration of Drawing. This change will allow students who are concentrating in Drawing the option of choosing between ART 383 (Intermediate Painting) or ART 217 (Printmaking II) in their third year, first semester. **Approved**
5. Course Change – ART 290 – The Department of Visual Art + Design requests a change in the prerequisite listing for ART 290 (New Media and Animation II). This change seeks to remove ART 151 and ART 111 from the list of prerequisites. **Approved**
6. Course Change – ART 288 – The Department of Visual Art + Design requests to add a description to the course ART 288 and the inclusion of “or ART 117” to the current list of prerequisites for ART 288 (Special Topics – Painting and Drawing). **Approved**
7. Course Change – ART 388 – The Department of Visual Art + Design requests a change in the listing of prerequisites for ART 388 (Special Topics – Drawing and Painting) to require only ART 299 (Sophomore Review). **Approved**
