

## **Council for Teacher Education**

The Council for Teacher Education met on Wednesday, October 17, 2007 at 3:00 p.m. in Room 2020 of the Cate Teacher Education Center. Julie Lester was present as a guest speaker for a Conceptual Framework presentation.

1. Dr. Rebecca Day called the meeting to order at 3:04 p.m.
2. Public school and student representatives introduced themselves and the areas they represent.
3. **Approval of Minutes:**  
Minutes of the meeting on September 19, 2007, were approved as submitted.

4. **Department of Teaching and Learning**

Dr. Nicki Anzelmo-Skelton, as proxy for Dr. Thornhill of the Department of Teaching and Learning, presented the following changes:

- A. Request to Add a Course: SPED 689. Teaming, Physical, and Medical Management in Early Intervention. 3 credit hours. Prerequisites: SPED 200, 210, or 600 or department consent. This course presents an overview of teaming and effective communication strategies for working with paraprofessionals and related service providers; the dynamics of interdisciplinary and interagency issues; the role of paraprofessionals and medical/related service personnel; normal development from conception to age five including development of the musculoskeletal systems, neurological systems and the influences of genetics, diseases, trauma and chemicals on the developing child.

Why was this proposal needed? To meet BESE requirements for newly redesigned graduate special education programs leading to add-on certification.

Motion for Item A was made, seconded and passed.

5. **Department of Foreign Languages and Literatures**

Dr. Lucia G. Harrison of the Department of Foreign Languages and Literatures presented the following changes:

- A. Request for Change: The K-12 redesign curricula for Spanish and French was presented. These changes have been approved by the State and are required for NCATE accreditation.

Motion for Item A was made by Dr. Salcedo, seconded and passed.

The Mock NCATE visit will be October 21-23, 2007. There will be a meeting of the CTE with the NCATE team on Monday, October 22, 2007, at 1:50 P.M. in TEC 2020.
