- II. Guest Speakers:
  - A. Dr. William Wainwright, President of Southeastern Louisiana University
    - 1. Faculty salary compression - Will be examined by administration.
    - 2. Legislative update - Bill to change from  $\frac{2}{3}$  vote of the legislature to change tuition, fee, cost, etc. to allow for easier request.  
Bill for deferred maintenance (backlogged maintenance needs at SELU is \$63 million) costs to be covered differently.  
Bill to restructure economic development for LA. Campus facility project costs were readjusted based  
DEI bills - Reporting on programs and projects that cover DEI. Bills modeled from other states' bills.  
Library bill - exemption for academic libraries.  
Constitutional convention for state constitution changes.
    - 3. Workday implementation - Registration has started.
    - 4. FAFSA - U.S. Dept of Ed redesigned financial aid process and it is delayed.
    - 5. Canvas - transition
    - 6. Transparency in campus safety - The Chief's Brief
    - 7. Mane Dish will be renovated over the summer.
    - 8. Transparency in finance - Communication concerning financial status will come through deans and dept heads

- e) Where do we sit financially? Federal gov't gave money during COVID to offset enrollment losses. That funding is no longer being received. Institution is progressing upward, but there is still a gap. Enrollment is up, but student credit hour generation also needs to be analyzed. "Laser focused" on enterprising opportunities because we will not enroll our way out of budget issues.
- f) Any changes to student recruitment beyond the region? Yes, the reach is increasing.
